

WARRANTY

The Veinte decorative bench top product (the “Veinte Product”) comes with one limited warranty and with no manufacturer’s warranty. The limited warranty is provided by its head supplier Veinte Imports.

You must examine the Veinte Product received from your supplier immediately upon receipt. Any faulty products must be reported to Veinte Imports within five (5) days from the date of delivery. If any raw sheet manufacturers fault/faults are discovered, the following limited warranty may apply.

Limited Warranty on Veinte Product

The terms of the Veinte Imports Limited Warranty are as follows:-

1. Limited Warranty

Veinte Imports warrants to the original purchaser of the Veinte Product that the Veinte Product will be free from any raw sheet manufacturers faults from the date of invoice for a period of 12 months. During this warranty period, Veinte Imports will, at its discretion, replace defective Veinte Products. This warranty does not cover damage due to external causes, including but not limited to, accident, abuse, misuse and fabrication faults, nor damage caused by heat, cold, scuffing, scratching, impact or normal wear and tear, nor usage not in accordance with the Veinte Product instructions. Some Veinte Products, clearly identified at the time of sale, are sold on an “as is” basis. These products do not carry any warranty. Our warranty only covers the Veinte Product. Veinte Imports is not responsible for any incidental loss.

2. Disclaimer of Warranty

This Limited Warranty is the only warranty applicable to the Veinte Product, and there are no warranties that extended beyond the face of this agreement. Veinte Imports hereby expressly disclaims all warranties, either expressed or implied, including any implied warranties of merchantability or fitness for any particular purpose. No oral or written information, photographs, advertisements or advice given by Veinte Imports, its agents or employees shall create a warranty or in any way increase the scope of this limited warranty.

3. Limitation of Liability

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state. Veinte Imports responsibility for any raw sheet manufacture fault/faults is limited to replacement as set forth in this warranty statement. All express and implied warranties for the Veinte Product, including but not limited to any implied warranties of and conditions of merchantability and fitness for a particular purpose, are limited in duration to the warrant period set forth above and no warranties, whether express or implied, will apply after such period. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Veinte Imports does not accept liability for incidental or consequential damages. Some states do not allow the exclusion or limitation of incidental or consequentially damages, do the above limitation or exclusion may not apply to you. These provisions only apply to the Veinte Imports warranty.

4. Claiming under Veinte Imports Limited Warranty.

You must contact Veinte Imports before the expiration of the warranty period in order to make any claim under Veinte Imports Limited Warranty.

5. Acknowledging Specific Exclusion from Veinte Imports Limited Warranty.

Veinte Products are hand made. There may be variations in:

- Pattern, and/or;
- Colour

between sheets of the Venite Product and, the colour of the Veinte Product may vary from sale samples. None of these variations shall constitute grounds for a claim under the Veinte Imports Limited Warranty.
